## Trip Cancellation Travel Insurance

### Primary Medical

### Cancel for Any Reason

Provides reimbursement for up to 75% of the prepaid, non-refundable, forfeited payments you paid for your trip up to \$15,000, if you cancel your trip for any reason not otherwise covered by this policy. Must be purchased with initial policy and within 14 days of the initial trip deposit or payment date, and the full, non-refundable trip cost is insured.

### Pre-Existing Medical Condition

Exclusion is waived if coverage is purchased within 14 days of the initial trip deposit or payment date, and the full, non-refundable trip cost is insured, and you are medically able to travel on the policy effective date.

### 14-Day Free Look

If you are not satisfied within 14 days of purchasing this plan, Trawick International will refund your premium cost if you have not departed on your trip or filed a claim.
